Requirements


- Requirements are defined as elements that the Office of the Governor, the CSDE, and/or the Connecticut State Department of Public Health have identified as necessary for the LEA to complete or comply with in order to open schools.
- Requirements = Mandatory



Guidance

- O Guidance is defined as considerations put forth by the CSDE or referenced entity rooted in best practice, experience, and research that will aid in the successful reopening of schools.
- Guidance = Suggested, not mandatory

Planning for Three Learning Programs

Full School Model

All students PreK-12 attend school full-time

Hybrid Model

Student classes split and attend 2 days & distant learn 3 days

Distant Learning Model

All students PreK-12 attend school online

Learning Programs

Learning Programs:

- <u>Full-Time Learning Program</u>: Students will attend school full-time in school per BOE approved calendar.
- <u>Distance Learning Program</u>: Students will attend school remotely from home per BOE approved school calendar. Thompson Public Schools will provide curriculum, instruction, and resources to support Distance Learning Program. Students are enrolled in Thompson Public Schools and may return to a full time in school learning program with a one-week written notice.
- o <u>Hybrid Program</u>: Students will attend school two days per week and learn remotely for three days per week. Students will be split into A and B Cohorts (Siblings will be on the same cohort schedule). This program reduces school and bus capacity by 50%.

A= Mon. & Tues. onsite – Wed., Thurs., Fri., Distance Learn

B= Thurs. & Fri. onsite - Mon., Tues., Wed., Distance Learn

Wednesday all students, faculty and staff Distance Learn – Schools undergo deep cleaning

Accommodations for Students with Special Education Needs

Students who receive special education services are entitled to appropriate accommodations for all learning program options.

If the district shifts to a hybrid model, students who require intensive special education services (self-contained and Bradley Windham County) may attend school onsite for four days if there is evidence of significant regression as documented by the student's progress data.

Distance Learning: TPS is 1:1



Technology

- All PreK, K, and Grade 1 students will receive a touch screen Chromebook in August (Grant Funded)
- All Grades 2, 3, & 4 students will receive a repurposed Chromebook in August
- All TMS students will receive Chromebooks in August if they currently do not have one at home
- All TMHS Students will receive new laptops in August (Grant Funded)

Program


- Classrooms will be set up to live stream instruction to students learning from home
- Teachers will receive personal ZOOM accounts to live stream instruction
- All teachers are required to use Google platform as the curriculum "home base"
- o Teachers will participate in professional development the week of August 24th to prepare for distance learning

TMHS Social Distance Plan

Cohort Groups

- Cohorts can not be established due to student schedules
- Classrooms will be removed of non-essential furniture to allow for social distancing between students
- Teachers will change classes, when feasible
- Class rotation schedule will be developed to limit the number of students passing in the corridors
- Larger classes of 20/21 will be scheduled in auditorium, stage area, library, or open lab

Transportation




Low Transmission Risk

- Students and families must follow bus transportation checklist before leaving for the bus stop
- All students and bus drivers are required to wear a face mask prior to boarding the bus
- School buses will operate at or near full capacity
- School buses will be disinfected between tiers
- Safety officers will assist drivers for the first two weeks of school with seating assignments, bus safety and health compliance

Moderate Transmission Risk

- Students and families must follow bus transportation checklist before leaving for the bus stop
- All students and bus drivers are required to wear a face mask prior to boarding the bus
- School buses will operate at fifty percent capacity during hybrid learning program
- School buses will be disinfected between tiers

Food Service



Breakfast and lunch may be picked up at TMS for students' distance learning

Breakfast and lunch will be sent to drop off areas if the district transitions to the hybrid model or complete distance learning.



Operations

- o All Schools have been completely disinfected
- PPE equipment (Masks, face shields, gowns, gloves, thermometers, desk shields) ordered and most delivered
- Plexi glass will be installed in school offices
- o Signs are currently being printed and will be installed throughout the campus
- o Dividers have been ordered to convert large spaces into classrooms
- HVAC System is being cleaned and serviced
- Water Systems are being flushed
- Bubblers closed (bottled water will be provided)
- Standard cleaning protocols are being developed to follow CDC guidelines
- Increase daytime custodial staff by transferring one from the night shift to days. Add additional sub custodians to clean outside play equipment and disinfect between am and pm preschool
- Ordering tents for outside mask breaks TMHS courtyard being upgraded to be used for outside classroom space

Health Monitoring Plan

- O All students, faculty, and staff are required to wear facemasks that cover the mouth and nose. Special exemptions will be determined on a case by case basis. Face shields and desk dividers have been ordered to accommodate individuals with exemptions.
- All students, faculty, and staff should be assessed at home (CDC Checklist) to determine they are fit to enter school
- All students, faculty, and staff will be required to wash hands frequently throughout the day
- An isolation room for ill students, faculty, and staff will be supervised by a CNA
- Signs will be posted throughout the complex and ongoing announcements reminding everyone of health protocols
- Faculty and staff will receive training on health protocols

Important Definitions


CASE: a person who has tested positive for COVID-19. Cases must isolate according to CDC guidelines

SUSPECTED CASE: a person with symptoms of COVID-19. suspected cases must isolate according to CDC guidelines

CONTACT: a person in Close Contact with a Case during and up to 2 days before the onset of symptoms

CLOSE CONTACT: Someone within 6 feet of an infected person for 15 minutes or more without a mask, PPE or physical barrier

NDDH: Classroom or School Closings
