Megan Parrette followed up regarding the hand sanitizer and ingredients. Shannon Grauer stated that you can review what is safe or not safe on the FDA website. Discussion was held.

Jessica Bolte asked if there is correspondence received from the Board of Finance about the overage from last year, and if it doesn't get approved, what does it do to the school budget moving forward. She also thanked Melinda Smith and the Board for being transparent during the school closure and bringing students back, and that parents are there to support in any way possible.

Valentine Iamartino stated that she is concerned that the Board of Finance is not listening to the Board of Education meetings. She also asked if the executive order lifts in September, does the school need to submit another back-to-school plan. Melinda Smith stated no, and there are 5 addendums that are available since the plan was submitted. Valentine Iamartino asked if mental health coverage will be available when students return to school. Melinda Smith stated that the schools will reach out to TEEG for assistance.
