 - ➤ Enrollment Update The June 2019 enrollment is at 972 students.
 - ➤ Teacher Recalls Melinda Smith is recommending calling back most of the recently laid-off teachers. The least senior kindergarten teacher and reading teacher at Mary R. Fisher Elementary School are going to remain laid off until the budget passes.
 - ➤ Legal Firm Kathleen Herbert stated that a committee interviewed four law firms. Although the committee is happy with Shipman & Goodwin, their hourly rates are increasing. The sub-committee has recommended Pullman & Comley to represent the Board of Education.

- ➤ Paraprofessional Layoffs Melinda Smith is recommending the lay-off of the two less-senior paraprofessionals, as a result of the original FY20 budget reductions.
- ➤ Use of 1909 Historical Education Rooms Melinda Smith has a proposal from Joseph Lindley
